- 51/18 Hertz: That the minutes of the regular meeting of council held on May 23, 2018 be approved as read. Carried.
- 52/18 Financial Owen: That the financial Statement and Bank Reconciliation for the month ended May, 2018 be approved as presented. Carried.
- 53/18 Financial Statement Greke: That the council approve the 2017 financial statement as presented. Carried.
